**For Purchase - CASH Only:**

- Can Box with Lid - \$7.00. (Extra lids are \$2.00 + tax.)
- Can Shed Liners - \$0.50 each. Receive a free replacement liner on day of redemption when bags are properly sorted.
- BottleDrop Bags - \$2.15 per box.

**Cans & Plastic Bottles - in Can Shed redemption liners**

- **Size Matters** - when containers are sorted by size and material it's easy to determine how many containers are in a bag. **Multiple sizes in bags will be paid out at the value of the largest size container in the bag** (i.e. 16oz-24oz bottles, properly sorted is \$7.20 in redemption value. When mixed with 2 Liters you will only receive the redemption value of the 2 Liters, which is only \$2.00.) Mixed bags of cans and plastic bottles will need to go through the RVM for proper credit.
- Containers must be clean and dry. (No bugs, excess liquid, garbage, cigarette butts, chew, straws, syringes, etc.) Expect to be turned away if your product contains any of the above.

**IOWA CODE 567-107.7(455) BEVERAGE CONTAINERS MUST BE REASONABLY CLEAN. Consumers shall take care to return containers in a reasonably clean and intact condition. To be redeemed, an empty beverage container shall be dry and free of foreign materials other than the dried residue of the beverage.**

- When using our bulk system there is no limit provided bags meet our guidelines. The cash payout limit is \$200.00 per household per day. Amounts over \$200.00 will receive a check by mail.
- Please hang onto your redemption containers & bags until you are checked in.
- **No deposit paid on flattened, non-deposit, or out-of-state containers.** (We will recycle, but no refund). Please keep these separate from deposit containers.

**IOWA CODE 567-107.8(2) In order to be redeemed, BEVERAGE CONTAINERS MUST BE REASONABLY INTACT. For a refillable beverage container, the container must be able to hold liquid, able to be resealed, and in its original shape. A non-refillable glass container may be chipped, but it may not have the bottom broken out or the neck broken off. A non-refillable aluminum container may be dented or partially crushed but may not be crushed flat. A returnable beverage container should be able to stand on its own base.**

## RVM: Cans & Plastic Bottles - non Can Shed redemption bag liner

For your convenience Can Shed now has Reverse Vending Machines at selected locations. Recycling your empty containers is as easy as:



1. **One customer per household per machine. Limited to 500 per day.**
2. **Insert your empty containers bottom first** into the chute at the front of the reverse vending machine.
3. When you're finished, **tap the button** at the front of the machine.
4. Steel cans and rejected deposit containers can be counted at the glass table.
5. **Take the receipt** that the machine prints out (the receipt shows the value of your recycling refund, which can be redeemed at the register.)
6. **RVM receipts must be cashed on the date of redemption.**
7. Place any **rejected** items in the designated bins for recycling.

## Glass

- For the safety of our employees, **we do not accept glass in bags.** If you do not have the original cases, banana boxes will be provided for you to organize the glass.
- Glass needs to be stacked with bottles lying flat (please see picture below).
- Each box should hold 60 beer bottles, or 20 wine or liquor bottles.



**Disclaimer:** Generally speaking, beverages that are carbonated and/or alcoholic are deposit eligible. We cannot redeem incorrectly marked containers or those that are distributed by a company whose choices do not comply with state rules. **We reserve the right to make the final judgement** whether to accept any container and pay the deposit and refuse service if guidelines are not followed.
